

# Terms of Service for Outfitr

## 1. Acceptance of Terms

By accessing <https://outfitr.co> or any related service (the “**Service**”), you agree to these Terms of Service (“**Terms**”) and to our Privacy Policy. If you do not agree, do not use the Service.

## 2. The Service

Outfitr lets users upload images and receive AI-generated virtual try-on outputs. We grant you a limited, non-exclusive, revocable license to use the Service for personal, non-commercial purposes.

## 3. Eligibility & Accounts

You must be at least **13 years old** and able to form a binding contract. Keep your credentials confidential; you are responsible for activity under your account.

## 4. User Content

- **License to Outfitr:** You grant Outfitr a worldwide, royalty-free license to host, process, and display your uploaded images and outputs **solely to operate and improve the Service**.
- **Permissions & legality:** You warrant you have the rights to the images you upload and that they don't violate any law or third-party rights.
- **Prohibited content:** No unlawful, hateful, or sexually explicit imagery intended for sexual arousal.
- **Public sharing:** Currently, all outputs are private. If we add public-sharing features, we will notify you first.

## 5. Credits, Payments & Refunds

- **Stripe** processes all payments.
- Credits **never expire**. If the Service fails to meet reasonable expectations, you may request a refund of unused credits within **30 days** of purchase (email [hello@outfitr.co](mailto:hello@outfitr.co)).
- We may change credit pricing with **30 days'** notice.

## 6. Acceptable Use

You will **not** reverse-engineer, scrape, interfere with, or disrupt the Service; upload malicious code; or use outputs for unlawful purposes.

## 7. Intellectual Property

All software, trademarks, and content (other than your User Content) are the property of **Artifakt LLC** or its licensors. All rights not expressly granted are reserved.

## 8. Disclaimers

The Service is provided “**as is**” without warranties of any kind, express or implied.

## 9. Limitation of Liability

To the maximum extent permitted by law, Outfitr will **not** be liable for indirect, incidental, or consequential damages. Our total liability will not exceed the greater of **US \$100** or the amount you paid us in the preceding **12 months**.
